

FREEDOM OF INFORMATION POLICY A GUIDE TO THE PUBLICATION SCHEME Spring 2020

Introduction

This guide has been produced as a requirement of the Information Commissioner's Office (ICO) and is based on a Model Publication Scheme.

The Model Publication Scheme and definition document provided by the ICO for schools was adopted by the Governing Body of Appleton thorn Primary School in April 2020. The Governing Body formally approved the detail and content of the Scheme via email in April 2020.

The Model Publication Scheme provides a list of the information routinely published by schools which the ICO expects them to make available unless:

- They do not hold the information
- The information is exempt under one of the FOI exemptions or Environmental Information Regulations (EIRs) exceptions, or its release is prohibited under another statute
- The information is archived, out of date or otherwise inaccessible; or, it would be impractical or resource-intensive to prepare the material for routine release
